FIREFIGHTER INTERN

\$16.75 - per hour (\$48,776 annual); Final Filing Date December 31, 2022

Position Description: The Firefighter Intern position is a 12-month position. Candidates are expected to commit to the full 12 months. At the end of 12 months, the Firefighter Intern will have met the requirements for Firefighter I or Firefighter II.

Minimum Qualifications: Must be at least 18 years old at the time of employment, valid driver's license, high school diploma or equivalent. Candidate must have certificate for Hazardous Materials First Responder, Confined Space Awareness, S-130, S-131, and S-190, and Title 22 medical training. Candidate must show proof of completion of one of the following: Volunteer Fire Academy, Firefighter I Academy, or California Firefighter I Certificate.

Application Process: Applications are available online at <https://www.northernsonomacountyfire.org/join>. Mail an original signed application to the Northern Sonoma County Fire Protection District, PO Box 217, Geyserville, CA 95441. Be prepared to bring your driver's license, copy of your high school diploma, or equivalent, and all applicable certificates to your oral interview. Failure to comply with the process and appropriate requirements will result in rejection of your application. The selection process will include application review, oral interview, background investigation, and physical exam.

Duties: Under the direct supervisor of a Fire Captain, the Firefighter Intern performs a variety of duties involving fire suppression, emergency response, protection of life and property, fire prevention, and other related activities.

Benefits: Employee will receive 48 hours of sick leave per year and uniform allowance. Employee is not entitled to health or retirement benefits in connection with this position.

Hours: Employee will be assigned to a shift and work 48 hours straight followed by 96 hours off. Intern Firefighters will be required to work as directed, possibly for multiple days on strike team assignments, but will be compensated in accordance with FLSA standards.
